## **City of Mercer Minutes for Organizational Meeting**

Ken Thomsen stated that it is time to Transfer the Gavel to Lori Haas. It has been an honor serving as your Interim Mayor. I now officially pass the gavel to our incoming Mayor, Lori Haas Stute. Congratulations and best of luck in your new role.
